Message from the Chair Palmerston North Māori Reserve Trust, Liz Mellish, MNZM

It is a pleasure to bring to you the current activities the Ahu Whenua Trusts have undertaken in 2024. Without doubt we have increased our activities, and you will see the emphasis we have placed to address our quadruple bottom line.

Whilst I appreciate that we have maintained our economic strategy and built our asset base continuously since we have taken complete control of managing that aspect of our business since

2004, we have never lost sight of our other pou. Our responsibilities as kaitiaki of our environmental, our cultural and social pou are top of mind in all our business decisions.

As a result the work trustees of Ngahuru Charitable Trust have done to undertake a refresh and bring in a new governance structure that includes our rangatahi is the right aspect to do now. There is more to come on this kaupapa as you will see in the various reports included in this pānui.

We are navigating our way as we face the new direction of the current coalition government. This has increased our workload considerably. The more complex nature of our asset portfolio has increased back-office functions. One exciting development is the work undertaken to locate owners and we are growing that each month as we track owners and pay out dividends not collected. This is pleasing to us all and staff have used their impressive computer skills to assist this mahi. There is still much delay in the Maori Land Court process and reducing staff has hampered them a lot.

The other key aspect of this pānui is to prepare you all for the two Annual General Meetings, Palmerston North Māori Reserve Trust in the Convention Centre Palmerston North on 24 August and Wellington Tenth Trust the following week at Te Raukura, Te Wharewaka o Pōneke on 31 August both starting at 10am. We all look forward to seeing you there with your rangatahi and whānau if possible.

I hope you are all well and keeping warm on these bitter days. Please keep up your vaccinations to prevent severe illness as COVID19, the Flu and RSV are very prevalent this winter in Aotearoa.

Our rōpū is lucky to have some knowledgeable kaihoe who are more than willing to share their experience, skills and time and is supported by our Ahu Whenua Trusts. However, we realise it is a challenging time for a lot of people in this current economic environment and with this in mind the aim of our Hoe Wānanga sessions this winter is to provide information that ultimately leads to opportunities.

Opportunities that may offer not just kōtahitanga, whakawhanaungatanga, and Mātauranga, but personal development and potential employment as many of our people would like to be involved with our tourism and education services.

If you enjoyed being involved with the FIFA Womens world cup welcome 'Hinemoana Ka Eke' you will be interested in having regular updates on other kaupapa that our hapori can be involved and that populate our calendar throughout the year.

During the summer months Wharewaka Tours provides tourism products to the trade industry and training for summer season will happen over the next few months. If learning about the hitōri of mana whenua in Te Whanganui a Tara and sharing this kōrero with Wellingtonians and international visitors interests you, then come along to our regular waka Kaupapa trainings scheduled below and begin the journey of connecting with us here at Te Raukura.

Te Rōpū Raranga o Manaia

Te Rā replica progress by Takiri Cotterill

As you will already be aware, our rōpū are weaving a replica of Te Rā which is currently on display in Auckland Museum.

In fact we have two Rā on the go, one lead by Kohai Grace and Linda Scott as well as our one which most of our accomplished weavers are participating in weaving. It is a beautiful, quiet atmosphere when the two Rā are out and the weavers are focused. We are so fortunate to be able to weave 2-3 days a month on our Rā thanks to the support of Hikoikoi Management Limited that allow us to get together over the weekend when Te Rōpū Raranga o Manaia is free. It takes two weavers about a day to weave one row. We are hoping to have the Rā completed in 18 months, and what a taonga it will be.

Presenting Te Rā

“I whakanuia e matou ia hei kuia me te tipuna”

“We honoured her as an elder and an ancestor”

At our April noho when Te Ra Ringa Raupa visited, many of you will have been at Hikoikoi when Niki Partsch from Heritage New Zealand visited, well her story has just been published:

There are some great insights in this article about how significant this project is to us and to weavers around Aotearoa.

Little is known about Te Rā, the only known Māori customary sail in existence. For many years she lay folded in the basement of the London Museum, the holder of cultural mātauranga and a physical embodiment of a lost technology.

Last month Te Rā Ringa Raupā, a group of dedicated Northland weavers, were in Petone to attend a series of wānanga and to share their incredible story. A journey of discovery and learning and of achieving their dream goal to re-create Te Rā. The group was hosted by Wellington weavers, Te Rōpū Raranga o Manaia and the shared wānanga (learning sessions) were held at the Whare Raumatī, Hikoikoi in Petone.

On the final day, in a room rich with the aroma of dried harakeke and the quiet sounds of fibres being twisted and woven, the visitors gave a presentation aptly named Te Karanga o Te Rā. A reference to the calling of the ancient sail herself.



Several members of the group shared their experiences of connection and learning. They explained how only a few weavers and researchers have been granted special access to Te Rā in recent times.

In 2010, renowned artist and weaver Dr Maureen Lander asked some of the group to travel to London to see Te Rā for themselves. There they would have the opportunity learn about the techniques employed to create her. This visit was a deeply emotional experience for them. “We honoured her as an elder and an ancestor,” says Ruth Port who was among the first group of expert weavers from Te Rā Ringa Raupā to travel to London.

The sail is comprised of thirteen finely woven harakeke (flax) panels and is over four metres in length. Puareare, an open weave zig zag pattern, diffuses the wind. The feathers of kāhu, kererū and kākā as well as a few tiny fragments of dog hair are artfully attached, probably just as adornments. “We each focussed on learning a particular thing,” says Tessa Harris another expert weaver.

The group felt a challenge from two sources, firstly from Te Rā herself, and secondly from the historical wero (challenge) laid down by renown Arts and Culture advocate Te Rangihīroa (Sir Peter Buck) in 1922, when he challenged Māori to revitalise traditional sail making skills. Back home in Aotearoa the group immediately began problem solving and perfecting new skills.

“This was a big goal to take on and we had to learn to weave together. That takes time,” says Ruth. “But if not for the British Museum caring for Te Rā all this time, we would have no reference to learn from.”

They first made a small version of Te Rā, named Hine Marama. Later they created a full-sized replica named Māhere Tū ki te Rangī. It took a full year to complete the sail. Both these sibling sails are also on display at Tāmaki Paenga Hira Auckland War Memorial Museum.

Te Rōpū Raranga o Manaia are actively working on their own re-creation of the sail. “Such a wealth of deep knowledge is held within Te Rā, it’s quite overwhelming. I am excited for the opportunity to gain further insights on our journey,” says group member Vanessa Tanner, who is also Manager Archaeology at Heritage New Zealand Pouhere Taonga.

“What Te Rā Ringa Raupā have done is amazing, we are so privileged and have gained a greater level of understanding into this technology from them.”

Pito One, Our Name

Recently Wellingtons Epuni Street was formally renamed Hōniana Te Puni Street to accurately reflect the tupuna (ancestor) the street is named after. Now lets take the opportunity to correct the spelling of the Lower Hutt suburb Petone to Pito One.

Consultation is now open on our proposal to correct the spelling of the Lower Hutt suburb Petone to Pito One. In late 2023 our proposal was submitted to Ngā Pou Taunaha o Aotearoa New Zealand Geographic Board on behalf of The Wellington Tenth Trust and the Palmerston North Māori Reserve Trust Trustees with support from the Hutt City Council and numerous other iwi groups from the region.

Pito One refers to the burial of pito (umbilical cord) in the one (sand) as a symbolic tethering of a newborn to the land and their tūrangawaewae (place to stand) and as an expression of ahi kā (continuous occupation). Pito One pā was the place where senior rangatira Hōniana Te Puni met William Wakefield and the New Zealand Company settlers in 1839.

Maree Robertson was accredited as a registered Problem Gambling Practitioner in early February 2024.

Gambling-related problems can lead to financial, social, emotional, occupational, and physical harm. The associated risks are serious for the economy, society and public health. Any individual who gambles is susceptible to developing a gambling problem.

The following are indicators that you or someone you love may have a gambling problem:

- Thinking about gambling all the time.
- Feeling the need to bet more money and more often.
- Going back to try and win your money back (“chasing losses”).
- Feeling restless or irritable when trying to stop or cut down.
- Feeling like you can’t control yourself.
- Gambling despite negative consequences.
- In extreme cases, problem gambling can cause bankruptcy, legal problems, losing your job or family.

Our statistics reveal that one in five people in Aotearoa will suffer from the consequences of gambling harm, either personally or due to someone else’s actions. Problem gambling disproportionately affects Māori, so it is imperative that we take action to address this issue.

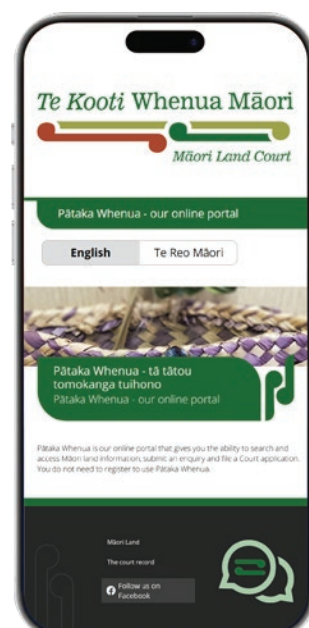
